# ARTICLES OF INCORPORATION

Executed by the undersigned for the purpose of forming a Wisconsin corporation under Chapter 181 of the Wisconsin statutes, WITHOUT STOCK AND NOT FOR PROFIT.

Article 1. The name of the corporation is

LAKESHORE REPEATER ASSOCIATION, INCORPORATED

Article 2. The period of existence shall be

Article 3. The purposes shall be educational & scientific with emphasis upon: a) enhancement of the value of the amateur radio service to the public as a voluntary, non-commercial communications service, particularly with respect to providing emergency communications; b) continuation and extension of the amateurs proven ability to contribute to the advancement of radio communications; c) encouragement and improvement of the amateur radio service in Racine and Kenosha counties by furnishing a forum for the exchange of ideas, a vehicle for educational purposes and technical facilities which provide advancing skills in both the communication and technical phases of radio communication; d) promoting the growth of amateur radio;

Provided that the purposes of the corporation shall at all times remain within the purview of Section 501.(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Article 10. (Membership provisions)

The corporation shall have one or more classes of members and a designation of such class or classes and the qualifications, rights, and method of acceptance of members of each class shall be set forth in the by-laws, provided however, that in no event shall the bi-laws qualify membership on the basis of race, creed, color, national origin or sex.

Article 11. (Other provisions)

- 11(a) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments of distributions and furtherance of the purposes set forth in Article 3. No substantial part of the activities of the corporation shall be the carrying of propaganda or otherwise to attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law or by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954) or the corresponding provision of any future United States Internal Revenue Law.
- 11(b) Upon the dissolution of the corporation, the board of trustees shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such matter, or to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501.(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the board of trustees shall determine. Any of such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.

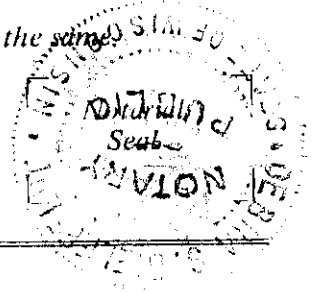
